ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District and the RT3.5 Residential Two-Flat, Townhouse and Multi-Unit District symbols as shown on Map No. 5-1 in the area bounded by:

A line 168 feet South of and parallel to West Wabansia Avenue; the public alley next East of and parallel to North Artesian Avenue; a line 216 feet South of and parallel to West Wabansia Avenue; North Artesian Avenue.

To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and approval. Common
