### ORDINANCE

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.**

**Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the C2-1, Motor Vehicle-Related Commercial District symbols as shown on Map No. 7-N in the area bounded by:**

**The public alley next North of and parallel to West Grand Avenue; North Newland Avenue; West Grand Avenue; North Sayre Avenue.**

**To those of a B2-5, Neighborhood Mixed-Use District**

**SECTION 2. This Ordinance takes effect after its passage and approval. Common address of property: 6936-74 West Grand Avenue, Chicago, Illinois.**

The subject property is currently vacant. The Applicant intends to divide the property into 8 zoning lots and build 6 four-story residential buildings, each with 8 dwelling units and 2 residential three-story buildings each with 12 dwelling units. The Applicant needs a zoning change to comply with the minimum lot area and the maximum floor area requirements of the Zoning Ordinance.
