ORDINANCE IMPERIAL LAM IAN Acct. No. 399098 - 1 Permit No. 1120374

Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to IMPERIAL LAMIAN, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use eleven (11) Awning(s) projecting over the public right-of-way adjacent to its premises known as 6 W. Hubbard St..

Said Awning(s) at N. State Street measure(s):

Seven (7) at ten point five eight (10.58) feet in length, and four point five (4.5) feet in width for a total of three hundred thirty-three point two seven (333.27) square feet.

Said Awning(s) at W. Hubbard Street measure(s):

Three (3) at ten point five eight (10.58) feet in length, and four point five (4.5) feet in width for a total of one hundred forty-two point eight three (142.83) square feet.

Said Awning(s) at N. State Street & W. Hubbard Street measure(s):

One (1) at twenty-nine (29) feet in length, and four point five (4.5) feet in width for a total of one hundred thirty point five (130.5) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1120374 herein granted the sum of fifty (\$50.00) per annum in advance.
