Yault(s) under the public right-of-way adjacent to its premises known as 523 S. Plymouth CL

. /Said Vault(s) at S. Plymouth Court measure(s):

•XOne (1) at twenty-three (23) feet in length, and fifteen (15) feet in width for a total of three hundred forty-five (345). square feet. Existing vault is used for storage.

% The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and m Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination).

.-. This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required :.. provisions of the Municipal Code of Chicago.

5-lihe grantee shall pay to the City of Chicago as compensation for the privilege #1120317 herein granted the sum of "i£f6ur hundred (\$400.00) per annum in advance.
