ORDINANCE
405 NORTH WABASH LLC Acct. No.
402092 -1 Permit No. 1120514

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 405 NORTH WABASH LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use one (1) Concrete and Metal Facia/Cladding(s) projecting over the public right-of-way adjacent to its premises known as 405 N. Wabash Ave..

Said Concrete and Metal Facia/Cladding(s) at N. Wabash Avenue measure(s):

One (1) at seventy-eight point zero eight (78.08) feet in length, and one point three three (1.33) foot in width for a total of one hundred three point eight five (103.85) square feet. Said decorative metal cladding shall be twenty-eight (28) feet in height.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

the grantee shall pay to the City of Chicago as compensation for the privilege #1120514 herein granted the sum of two thousand eight hundred ninety-five (\$2,895.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
