Section 10-20-430 of the Municipal Code of Chicago, the Commissioner of Transportation is hereby authorized and directed to exempt Dollar Express / Ashland FD LLC from the provisions requiring barriers as a prerequisite to prohibit alley ingress and egress to parking facilities for premise address at 4524 South Ashland Avenue.
