ORDINANCE RESTAURANT 2
AMIGOS ,Acct. No. 4448 -1 Permit No.
1120764

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to RESTAURANT 2 AMIGOS, upon the terms and subject to the conditions of this ordinance to maintain and use a portion of the public right-of-way for Occupation of Space adjacent to its premises known as 2320 N. Milwaukee Ave.. Existing occupation of space is used for an enclosure for the purpose of housing a trash compactor in order to comply with the Department of Streets and Sanitation orders. Existing enclosure measure seven (7) feet in length and five (5) feet in width for a total of thirty-five (35) square feet. Enclosure is located along West Belden Avenue adjacent to the restaurant.

Grantee must allow at least six (6) feet of clear and unobstructed space for pedestrian passage at all times.

fine location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development, Department of Transportation (Division of Project Development), and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1120764 herein granted the sum of four hundred (\$400.00) per annum in advance.

A-25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 12/13/2015. /
