BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 10-J in the area bounded by

The public alley next north of and parallel to West 47 Street; South Springfield Avenue; West 47th Street; and a line 68.06 feet west of and parallel to South Springfield Avenue,

to those of a BI-1 Neighborhood Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
