ORDINANCE

1650-1654 W. DIVISION, LLC Acct.
No. 399944 - 1 Permit No. 1119687

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 1650-1654 W. DIVISION, LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use eight (8) Balcony(s) projecting over the public right-of-way adjacent to its premises known as 1664 W. Division St..

Said Balcony(s) at W. Division Street measure(s):

One (1) at seventeen point five (17.5) feet in length, and five point nine two (5.92) feet in width for a total of one hundred three point six (103.6) square feet.

One (1) at thirty point seven five (30.75) feet in length, and six point nine two (6.92) feet in width for a total of two hundred twelve point seven nine (212.79) square feet.

One (1) at thirty point seven five (30.75) feet in length, and six point nine two (6.92) feet in width for a total of two hundred twelve point seven nine (212.79) square feet.

One (1) at twenty-five point four two (25.42) feet in length, and six point nine two (6.92) feet in width for a total of one hundred seventy-five point nine one (175.91) square feet.

One (1) at twenty-five point four two (25.42) feet in length, and six point nine two (6.92) feet in width for a total of one hundred seventy-five point nine one (175.91) square feet.

One (1) at twelve point six six (12.66) feet in length, and five point nine two (5.92) feet in width for a total of seventy-four point nine five (74.95) square feet.

One (1) at twelve point six six (12.66) feet in length, and five point nine two (5.92) feet in width for a total of seventy-four point nine five (74.95) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1119687 herein granted the sum of six hundred (\$600.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
