Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to CA RESIDENTIAL STATE/HURON, LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use two (2) Sheeting(s) under the public right-of-way adjacent to its premises known as 8 E. Huron St..

Said Sheeting(s) at N STATE ST measure(s):

One (1) at sixty-three point nine two (63.92) feet in length, and one point two five (125) foot in width for a total of seventynine point nine (79.9) square feet. Said sheeting shall be approximately fifty (50) feet below grade level.

Said Sheeting(s) at ALLEY (ADJACENT TO N STATE ST) measure(s):

One (1) at eighty-six point one seven (86.17) feet in length, and one point two five (1.25) foot in width for a total of one hundred seven point seven one (107.71) square feet. Said sheeting shall be approximately fifty (50) feet below grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1121020 herein granted the sum of eight hundred (\$800.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs
