ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 1 H in the area bounded by:

the public alley next north of West Washington Boulevard; a line 62.75 feet east of the east line of North Hoyne Avenue; West Washington Boulevard; and a line 19.75 feet east of the east line of North Hoyne Avenue;

to those of a BI-1 Neighborhood Shopping District.

SECTION 2. This ordinance takes effect after its passage and approval.
