ORDINANCE CHRIST THE KING Acct. No. 354630 - 1 Permit No. 1121201

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to CHRIST THE KING, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, seventy-one (71) Irrigation System(s) under the public right-of-way adjacent to its premises known as 5088 W. Jackson Blvd..

Said Irrigation System(s) at W. Quincy measure(s):

Twenty-nine (29) at three hundred (300) feet in length, and twelve (12) feet in width for a total of one hundred four thousand four hundred (104400) square feet.

Said Irrigation System(s) at W. JAcKson Blvd measure(s):

Thirty-four (34) at three hundred fifty (350) feet in length, and eight (8) feet in width for a total of ninety-five thousand two hundred (95200) square feet.

Said Irrigation System(s) at W. JAcKson Blvd measure(s):

Eight (8) at sixty-five (65) feet in length, and ten (10) feet in width for a total of five thousand two hundred (5200) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination) and Department of Water Management.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1121201 herein granted the sum of four hundred (\$400.00) per annum in advance.

. A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 09/08/2015.
