ORDINANCE

THE RESIDENCES CONDOMINIUM ON THE MAGNIFICENT MILE CONDOMINIUM ASSOCIATION Acct. No. 389577 - 1 Permit No. 1121177

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to THE RESIDENCES CONDOMINIUM ON THE MAGNIFICENT MILE CONDOMINIUM ASSOCIATION, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, twelve (12) Exterior mount(s) projecting over the public right-of-way adjacent to its premises known as 118 E. Erie St..

Said Exterior mount(s) at E. Erie measure(s):

Two (2) at two (2) feet in length, and four point eight four (4.84) feet in width for a total of nineteen point three six (19.36) square feet. Existing exterior mount is approximately sixteen (16) inches above grade level.

Said Exterior mount(s) at E. Erie measure(s):

Two (2) at two (2) feet in length, and point six (.6) feet in width for a total of two point four (2.4) square feet. Existing exterior mount is approximately seventy-four (74) inches above grade level.

Said Exterior mount(s) at N. Michigan measure(s):

Four (4) at two (2) feet in length, and two point five (2.5) feet in width for a total of twenty (20) square feet. Existing exterior mount is approximately sixteen (16) inches above grade level.

Said Exterior mount(s) at N. Michigan measure(s):

Four (4) at two (2) feet in length, and point five (.5) feet in width for a total of four (4) square feet. Existing exterior mount is approximately seventy-four (74) inches above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1121177 herein granted the sum of zero (\$.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years and after 01/13/2016.
