Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to OBERWEIS DAIRY, INC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Park bench(s) on the public right-of-way adjacent to its premises known as 3055 N. Sheffield Ave..

Said Park bench(s) at W. Barry Avenue measure(s):

One (1) at six (6) feet in length, and two (2) feet in width for a total of twelve (12) square feet. Said

Park bench(s) at N. Sheiffeld Avenue measure(s):

One (1) at six (6) feet in length, and two (2) feet in width for a total of twelve (12) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1121243 herein granted the sum of one hundred fifty (\$150.00) per annum in advance.
