ORDINANCE DOLLAR
EXPRESS Acct. No. 401342-
5 Permit No. 1120843

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to DOLLAR EXPRESS, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Fire Shutter(s) projecting over the public right-of-way adjacent to its premises known as 4314 S. Kedzie Ave..

Said Fire Shutter(s) at S. Kedzie Avenue measure(s):

One (1) at ten point eight three (10.83) feet in length, and two (2) feet in width for a total of twenty-one point six six (21.66) square feet.

One (1) at twelve point six seven (12.67) feet in length, and two (2) feet in width for a total of twenty-five point three four (25.34) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1120843 herein granted the sum of eight hundred (\$800.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

Authority herein given and granted for a period of five (5) years/rom and after Date of Passage.
