BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District symbols and indications as shown on Map No. 3-H in the area bounded by

The public alley next north of and parallel to West Division Street; a line 104.64 feet east of and parallel to North Hoyne Avenue; West Division Street; a line 79.64 feet east of and parallel to North Hoyne Avenue,

to those of a CI-2 Neighborhood Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about March 24, 2016, I, the undersigned, will file an application for a change in zoning from a B3-2 Community Shopping District to a C1-2 Neighborhood Commercial District on behalf of REAL SIMPLE INC.

The applicant seeks a zoning amendment to a C1-2 Neighborhood Commercial District in order to allow a tavern which is within 400 feet of an existing tavern.

The applicant intends to use the subject property to allow a tavern in an existing 3-story building, which currently utilizes 2300 sq.ft. on the first and second floors as a full service restaurant with an incidental liquor license and a public place of amusement license. The third floor is and will remain an office. The premises are located at 2050 W. Division Street.

Changes will be made to the building's height with a proposed 2-story addition at the rear of the property. The first floor addition will add 1408 sq.ft. to the existing 1240 sq.ft. totaling 2648 sq.ft. on the 1st floor. The second floor addition will add 1588 sq.ft. to the existing 1060 sq.ft. for a total of 2648 sq.ft. on the 2nd floor. The rear 2-story addition height will be 26'9". The total proposed tavern space on floors 1 and 2 will be 5296 sq.ft. No changes will be made to the existing third floor which currently has 1100 sq.ft. of office space and a height of 33'9". The basement space is being excavated to a height of 8' to install a new full-service kitchen for the restaurant.

The applicant is Real Simple Inc., 2050 W. Division; Chicago, IL 60622. The sole officer and shareholder is Joe Lin. The property owner is 2050 Division LLC, 2050 W. Division, Chicago, Illinois 60622. Joe Lin and Jack Lin are managing members of 2050 Division LLC.
