### ORDINANCE

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.**

**Title 17 of the Municipal Code of\* Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 5-M in the area bounded by:**

**A line 74.75 feet North of and almost parallel to West Palmer Street (as measured along the West boundary line of North Merrimac Avenue); North Merrimac Avenue; a line 44.75 feet North of and almost parallel to West Palmer Street (as measured along the West boundary line of North Merrimac Avenue); the public alley next West of and parallel to North Merrimac Avenue.**

To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District SECTION 2.

This Ordinance takes effect after its passage and due publication. Common address of
