ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the RT4 Residential Two-Flat, Townhouse and multi-Unit District symbols and indications as shown on Map No 4-G in the area bounded by

a line 210 feet south of and parallel to West 16th Street; South Morgan Street; a line 234 feet south of and parallel to West 16th Street; and the alley next west of and parallel to South Morgan Street,

to those of a RM4.5 Residential Multi-Unit District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
