PARTNERS Acct. No. 303532
- 1 Permit No. 1123516

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to G&W PARTNERS, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Vault(s) under the public right-of-way adjacent to its premises known as 741 W. Randolph St..

Said Vault(s) at 747 W. Randolph Street measure(s):

One (1) at sixty-one point four one (61.41) feet in length, and eleven point five (11.5) feet in width for a total of seven hundred six point two two (706.22) square feet.

Said Vault(s) at 125 N. Halsted measure(s):

One (1) at one hundred fifty-two point two four (152.24) feet in length, and five point five (5.5) feet in width for a total of eight hundred thirty-seven point three two (837.32) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1123516 herein granted the sum of eight hundred (\$800.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs

associated with damage, relocation or removal of private property caused by the City performing work in the public way.
