ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1. Title 17 ofthe Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all ofthe RT-3.5 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 7-1 in the area bounded by

A line 275 feet south of and parallel to West Schubert Avenue; The north south public alley east of and parallel to North Washtenaw Avenue; the east west public alley south of and parallel to West Schubert Avenue; North Washtenaw Avenue;

to those of a RS-3 Residential Single-Unit (Detached House) District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
