AMENDED ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by inserting the underscored language and deleting the language struck through, as follows:

4-60-022 Restrictions on additional licenses.

Subject to the provisions of subsection 4-60-021 (c), no additional license shall be issued for the sale of alcoholic liquor, for consumption on the premises within the following areas:

(Omitted text is unaffected by this ordinance)

- 23) On the west side of Western Avenue, from 117th Street to 119th Street.
- 24) On the north side of 115th Street, from Kedzie Avenue to Spaulding Avenue.

(Omitted text is unaffected by this ordinance)

SECTION 2. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by inserting the underscored language and deleting the language struck through, as follows:

4-60-023 Restrictions on additional package goods licenses.

Subject to the provisions of subsection 4-60-021 (c), no additional package goods license shall be issued for any premises located within the following areas:

(Omitted text is unaffected by this ordinance)

- 23) On the north side of 115th Street, from Kedzie Avenue to Spaulding Avenue.
- 24) On the west side of Western Avenue, from 99th Street to 101st Street.
- 25) On the west side of Western Avenue, from 101st Street to 103rd Street.
- 26) On the west side of Western Avenue, from 103rd Street to 105th Street.
- 27) On the west side of Western Avenue, from 105th Street to 107th Street.
- 28) On the west side of Western Avenue, from 107th Street to 109th Street.
- 29) On the west side of Western Avenue, from 109th Street to 111th Street.

- 30) On the west side of Western Avenue, from 111th Street to 113th Street.
- 31) On the west side of Western Avenue, from 113th Street to 115th Street.
- 32) On the west side of Western Avenue, from 115th Street to 117th Street.
- 33) On the westside of Western Avenue, from 117th Street to 119th Street.
