ORDINANCE U-STOR-IT Acct. No. 405774 -1 Permit No. 1124041

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to U-STOR-IT, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use three (3) Door Swing(s) on the public right-of-way adjacent to its premises known as 1245 W. 15th St..

Said Door Swing(s) at S. Throop Street measure(s):

Two (2) at three (3) feet in length, and three point three three (3.33) feet in width for a total of nineteen point nine eight (19.98) square feet.

Said Door Swing(s) at W. 15th Street measure(s):

One (1) at two point eight three (2.83) feet in length, and three point three three (3.33) feet in width for a total of nine point four two (9.42) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1124041 herein granted the sum of two hundred twenty-five (\$225.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
