BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following locations are hereby designated as Loading Zones for the distances specified, during the hours specified:

LOADING ZONES / STANDING ZONES: WARD 1 North Fairfield Avenue; North Fairfield Avenue (west side) from a point 312 feet north of West Wabansia Avenue to a point 207 feet north thereof; 15 Minute Standing Zone, 7:30am to 3:30pm, School Days, Public Benefit - (16-04935169) [02016-4917] 1 North Paulina Street; North Paulina Street (east side) from a point 15 feet north of West Division Street to a point 30 feet thereof; No Parking Loading Zone, 9:00am to 2:00am, All Days [02016-7247] 10 8805 South Burley Avenue; 15 Minute Standing Zone, 7:00am to 6:00pm, Monday through Saturday [02016-7164] 10 10232 South Avenue N; No Parking Loading Zone, Monday through Friday [O2016-7163] 8712 South Commercial Avenue; No Parking Loading Zone, 7:00am to 6:00pm, 10 Monday through Saturday [02016-7165]
