ORDINANCE
AKARRASEL CHILD CARE CENTERS Acct.
No. 27879 - 1 Permit No. 1124679

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to AKARRASEL CHILD CARE CENTERS, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Trash container(s) on the public right-of-way adjacent to its premises known as 5504 W. Fullerton Ave..

Said Trash container(s) at W. Fullerton Ave/Public Alley measure(s):
Two (2) at two point six seven (2.67) feet in length, and two point six seven (2.67) feet in width for a total of fourteen point two six (14.26) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1124679 herein granted the sum of one hundred fifty (\$150.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
