**TRAFFIC LANE - TOW ZONES** 

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

Zone, 8:00pm to 8:00am, All Days [02016-5436]

SECTION 1. Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, the following locations are hereby designated as Traffic Lane - Tow Zones, between the limits and during the times specified, standing or parking of any vehicle shall be considered a definite hazard to the normal movement of traffic:

#### WARD TOW ZONES:

I	North Humboldt Boulevard; North Humboldt Boulevard (east side) from West Armitage Avenue to West Palmer Street; No Parking Tow Zone, 7:00pm to 11:00pm, Tuesday and Friday, 8:00am to 4:00pm, Sunday [02016-7766]
II	South Racine Avenue; South Racine Avenue (east side) from West 14th Place to West 15th Street; No Parking Tow Zone, All Times, All Days (16-05629149) [02016-5645]
11	South Aberdeen Street; South Aberdeen Street (east and west side) from West 14th Place to a point 50 feet south of West 15th Street; No Parking Tow Zone, All Times, All Days - (16-05628912) [02016-5644]
14	West 51st Street; West 51st Street (south side) from South Meade Avenue to South Moody Avenue; No Parking Tow Zone, 8:00am to 4:00pm, Monday through Friday(16-05082179) [O2016-5655]
28	4600-4630 West Gladys Avenue; West Gladys Avenue (north side); No Parking Tow
