ORDINANCE HARRY WINSTON Acct. No. 324128-1 Permit No. 1124499

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to HARRY WINSTON, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use seven (7) Awning(s) projecting over the public right-of-way adjacent to its premises known as 55 E. Oak St..

Said Awning(s) at E. Oak Street measure(s):

Two (2) at five (5) feet in length, and one point eight three (1.83) foot in width for a total of eighteen point three (18.3) square feet.

Said Awning(s) at E.Oak Street measure(s):

Two (2) at five (5) feet in length, and one point eight three (1.83) foot in width for a total of eighteen point three (18.3) square feet.

Said Awning(s) at E. Oak Street measure(s):

Three (3) at five (5) feet in length, and one point eight three (1.83) foot in width for a total of twenty-seven point four five (27.45) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1124499 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.
