ORDINANCE
HART 353 NORTH CLARK, LLC Acct. No.
397831 - 2 Permit No. 1124873

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to HART 353 NORTH CLARK, LLC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Grease Basin(s) under the public right-of-way adjacent to its premises known as 353 N. Clark St..

Said Grease Basin(s) at N. Dearborn measure(s):

One (1) at one (1) foot in length, and three point five (3.5) feet in width for a total of three point five (3.5) square feet. Said

Grease Basin(s) at N. Clark measure(s):

One (1) at one (1) foot in length, and four point six six (4.66) feet in width for a total of four point six six (4.66) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination) and Department of Water Management.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1124873 herein granted the sum of eight hundred (\$800.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) yearsJ^i^md after 11/02/2016.
