ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION I. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Residential Planned Development Number 961 symbols and indications as shown on Map Number 8-G in the area bounded by:

The alley next north of and parallel to West 35th Street; a line 510.53 feet east of and parallel to South Aberdeen Street; West 35th Street; and South Aberdeen Street

To the designation of a C3-5 Commercial, Manufacturing and Employment District. SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
