BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Bl-2 Neighborhood Shopping District and B3-2 Community Shopping District symbols and indications as shown on Map No. 13-J in the area bounded by

A line 196.25 feet east of and parallel to North Kimball Avenue; a line 125.00 feet south of and parallel to West Foster Avenue; North Kimball Avenue; and West Foster Avenue,

to those of a B3-2 Community Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
