ORDINANCE
FSP 303 EAST WACKER DRIVE CORP Acct. No.
351382 - 1 Permit No. 1124704

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to FSP 303 EAST WACKER DRIVE CORP, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, three (3) Exhaust Duct (s) projecting over the public right-of-way adjacent to its premises known as 303 E. Wacker Dr..

Said Exhaust Duct(s) at Middle East Wacker Dr measure(s):

One (1) at one (1) foot in length, and one (1) foot in width for a total of one (1) square feet. Existing exhaust duct is approximately eight (8)feet above grade level.

One (1) at one point six six (1.66) foot in length, and point five (.5) feet in width for a total of point eight three (.83) square feet. Existing exhaust duct is approximately eight (8) feet above grade level.

One (1) at one (1) foot in length, and one (1) foot in width for a total of one (1) square feet. Exhaust duct is approximately eight (8) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1124704 herein granted the sum of one thousand two hundred (\$1,200.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) yearsJfai^nd after 07/28/2015.
