ORDINANCE

854 WEST RANDOLPH LLC Acct. No.

407180 -1 Permit No. 1124669

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 854 WEST RANDOLPH LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use two (2) Ice Melt System(s) under the public right-of-way adjacent to its premises known as 846-54 W. Randolph St..

Said Ice Melt System(s) at W. Randolph Street measure(s):

One (1) at one hundred nine point two five (109.25) feet in length, and fifteen point seven five (15.75) feet in width for a total of one thousand seven hundred twenty point six nine (1720.69) square feet.

Said Ice Melt System(s) at N. Peoria Street measure(s):

One (1) at one hundred fifteen (115) feet in length, and nine point two five (9.25) feet in width for a total of one thousand sixty-three point seven five (1063.75) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section. 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1124669 herein granted the sum of one thousand one hundred twenty-six (\$1,126.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs
