ORDINANCE

PORETTA'S RESTAURANT Acct. No.

16353-1 Permit No. 1125242

Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to PORETTA'S RESTAURANT, upon the terms and subject to the conditions ofthis ordinance to maintain and use, as now constructed, four (4) Awning(s) projecting over the public right-of-way adjacent to its premises known as 3656 N. Central Ave..

Said Awning(s) at Corner of Central And Waveland measure(s):

One (1) at eighty point seven five (80.75) feet in length, and two point eight three (2.83) feet in width for a total of two hundred twenty-eight point five two (228.52) square feet.

Said Awning(s) at Waveland Ave measure(s):

Three (3) at thirteen point four two (13.42) feet in length, and three (3) feet in width for a total of one hundred twenty point seven eight (120.78) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1125242 herein granted the sum of twenty-five (\$25.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs
