ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code, the Chicago Zoning Ordinance, be amended by changing all the RS3 Residential Single-Unit (Detached House) District, and RM5 Residential Multi-Unit District symbols and indications as shown on Map No.1-I in the area bounded by

West Huron Street; a line 125 feet east of and parallel to North Washtenaw Avenue; the

alley next south of West Huron Street; and a line 75 feet east of and parallel to North Washtenaw Avenue,

to those of a RM4.5 Residential Multi-Unit District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
