### *Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. That the Commissioner of Buildings is hereby authorized and directed to issue a sign permit to 365 Outdoor, LLC, 430 W. Erie, Suite 400, Chicago, IL 60654, for the erection of a sign/signboard over 24 feet in height and/or over 100 square feet (in area of one face) at 1214 N Damen, Chicago, IL 60622, with the dimensions, height and square foot area:
