ORDINANCE PUBLICAN
ANKER Acct. No. 273474 - 1
Permit No. 1125502

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to PUBLICAN ANKER, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use eleven (11) Light Fixture(s) projecting over the public right-of-way adjacent to its premises known as 1576 N. Milwaukee Ave..

Said Light Fixture(s) at N. Damen Avenue measure(s):

Two (2) at one (1) foot in length, one point six six (1.66) foot in width and sixteen point six seven (16.67) feet above grade level.

Said Light Fixture(s) at N. Damen Avenue & N. Milwaukee Avenue measure(s):

Three (3) at one (1) foot in length, one point six six (1.66) foot in width and sixteen point six seven (16.67) feet above grade level.

Said Light Fixture(s) at N. Milwaukee Avenue measure(s):

Six (6) at one (1) foot in length, one point six six (1.66) foot in width and sixteen point six seven (16.67) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1125502 herein granted the sum of one hundred twenty-five (\$125.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
