Be It Ordained by the City Council of the City of Chicago:

SECTION 1. That the Commissioner of Buildings is hereby authorized and directed to issue a sign permit to 365 Outdoor, LLC, 430 W. Erie, Suite 400, Chicago, IL 60654, for the erection of a rooftop sign/signboard over 24 feet in height and/or over 100 square feet (in area of one face) at 1965 N. Milwaukee, Chicago, IL 60647, with the dimensions, height and square foot area:

Dimensions: Length, 48 feet; Height, 14 feet Height Above

Grade/Roof to Top of Sign: 65 feet Total Square Foot Area: 672

square feet
