*Be It Ordained by the City Council of the City of Chicago:*

**SECTION 1. That the Commissioner of Buildings is hereby authorized and directed to issue a sign permit to 365 Outdoor, LLC, 430 W. Erie, Suite 400, Chicago, IL 60654, for the erection of a rooftop sign/signboard over 24 feet in height and/or over 100 square feet (in area of one face) at 1965 N. Milwaukee, Chicago, IL 60647, with the dimensions, height and square foot area:**

**Dimensions: Length, 48 feet; Height, 14 feet Height Above Grade/Roof to Top of Sign: 65 feet Total Square Foot Area: 672 square feet**

**Notwithstanding any provisions of Title 17 of the Municipal Code of the City of Chicago (the Chicago Zoning Ordinance) to the contrary, the Commissioner of Buildings is hereby directed and authorized to issue a sign permit to the address referenced within this ordinance.**
