#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 9-L in the area bounded by:

West Eddy Street; a line 333.61 feet West of and parallel to North Cicero Avenue; a line 102.17 feet South of and parallel to West Eddy Street; a line 371.12 feet West of and parallel to North Cicero Avenue.

To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District SECTION 2.
