### ORDINANCE

#### ***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

SECTION 1. The City Council finds that the areas described in Section 2 of this ordinance are adversely affected by the over-concentration of businesses licensed to sell alcoholic liquor within and near the areas.

SECTION 2. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by inserting the underscored language as new subsections 4-60-023 (19.41 through 19.69), as follows:

#### **4-60-023 Restrictions on additional package goods licenses.**

Subject to the provisions of subsection 4-60-021 (c), no additional package goods license shall be issued for any premises located within the following areas:

- 41) On Kedzie Avenue, from 103<sup>rd</sup> Street to 105<sup>th</sup> Street.
- 42) On Kedzie Avenue, from 105<sup>th</sup> Street to 106<sup>th</sup> Street.
- 43) On Kedzie Avenue, from 106<sup>th</sup> Street to 108<sup>th</sup> Street.
- 44) On Kedzie Avenue, from 108<sup>th</sup> Street to 110<sup>th</sup> Street.
- 45) On Kedzie Avenue, from 110<sup>th</sup> Street to 112<sup>th</sup> Place.
- 46) On Kedzie Avenue, from 112<sup>th</sup> Place to 114<sup>th</sup> Street.
- 47) On Kedzie Avenue, from 114<sup>th</sup> Street to 115<sup>th</sup> Street.

- 48) On 111<sup>th</sup> Street, from Cicero Avenue to Kilpatrick Avenue.
- 49) On 111<sup>th</sup> Street, from Kilpatrick Avenue to Kilbourn Avenue.
- 50) On 111<sup>th</sup> Street, from Kilbourn Avenue to Kostner Avenue.
- 51) On 111<sup>th</sup> Street, from Kostner Avenue to Pulaski Road.
- 52) On 111<sup>th</sup> Street, from Pulaski Road to Springfield Avenue.
- 53) On 111<sup>th</sup> Street, from Springfield Avenue to Lawndale Avenue.
- 54) On 111<sup>th</sup> Street, from Lawndale Avenue to Central Park Avenue.
- 55) On 111<sup>th</sup> Street, from Central Park Avenue to St. Louis Avenue.

- 56) On 111<sup>th</sup> Street, from St. Louis Avenue to Homan Avenue.
- 57) On 111<sup>th</sup> Street, from Homan Avenue to Spaulding Avenue.
- 58) On 111<sup>th</sup> Street, from Spaulding Avenue to Kedzie Avenue.
- 59) On 111<sup>th</sup> Street, from Kedzie Avenue to Albany Avenue.
- 60) On 111<sup>th</sup> Street, from Albany Avenue to Sacramento Avenue.
- 61) On 115<sup>th</sup> Street, from Cicero Avenue to 44<sup>th</sup> Place.
- 62) On 115<sup>th</sup> Street, from 44<sup>th</sup> Place to Keeler Avenue.
- 63) On 115<sup>th</sup> Street, from Keeler Avenue to Karlov Avenue.
- 64) On 115<sup>th</sup> Street, from Karlov Avenue to Pulaski Road.
- 65) On 115<sup>th</sup> Street, from Pulaski Road to Hamlin Avenue.
- 66) On 115<sup>th</sup> Street, from Hamlin Avenue to Central Park Avenue.
- 67) On 115<sup>th</sup> Street, from Central Park Avenue to Homan Avenue.
- 68) On 115<sup>th</sup> Street, from Homan Avenue to Kedzie Avenue.
- 69) On Cicero Avenue, from 111<sup>th</sup> Street to 115<sup>th</sup> Street.
