ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C2-2 Motor Vehicle-Related Commercial District, B3-2 Community Shopping District and B3-3 Community Shopping District symbols and indications as shown on Map No. 18-C in the area bounded by

South Stony Island Avenue; East 71st Street; South Constance Avenue; a line 60 feet south of and parallel to East 71st Street; a line 134.45 feet west of and parallel to South Constance Avenue; a line 167 feet north of and parallel to East 71st Place; a line 226.92 feet west of and parallel to South Constance Avenue; a line 167.06 feet south of and parallel to East 71st Street; the public alley next east of and parallel to South Ridgeland Avenue; the public alley next south of and parallel to East 71st Street; the public alley next west of and parallel to South Ridgeland Avenue; the public alley next south of and parallel to East 71st Street; the public alley next east of and parallel to South East End Avenue; a line 100 feet south of and parallel to East 71st Street; South East End Avenue; a line 53 feet south of and parallel to East 71st Street; the public alley next west of and parallel to South East End Avenue; a line 78 feet south of and parallel to East 71st Street; South Cornell Avenue; a line 53 feet south of and parallel to East 71st Street; the public alley next east of and parallel to South Stony Island Avenue; and a line 128 feet south of and parallel to East 71st Street,

to those of an RS3 Residential Single-Unit (Detached House) District.
