ORDINANCE Haymarket Pub &
Brewery Acct. No. 351881 -1
Permit No. 1126530

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to Haymarket Pub & Brewery, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, nine (9) Awning(s) projecting over the public right-of-way adjacent to its premises known as 737-741 W. Randolph St..

Said Awning(s) at W Randolph measure(s):

Two (2) at fifteen point six seven (15.67) feet in length, and three (3) feet in width for a total of ninety-four point zero two (94.02) square feet.

Said Awning(s) at N Halsted measure(s):

Two (2) at sixteen point one seven (16.17) feet in length, and three (3) feet in width for a total of ninety-seven point zero two (97.02) square feet.

One (1) at sixteen point four two (16.42) feet in length, and three (3) feet in width for a total of forty-nine point two six (49.26) square feet.

One (1) at fourteen point one seven (14.17) feet in length, and three (3) feet in width for a total of forty-two point five one (42.51) square feet.

Two (2) at fifteen point six seven (15.67) feet in length, and three (3) feet in width for a total of ninety-four point zero two (94.02) square feet.

One (1) at thirteen point three three (13.33) feet in length, and three (3) feet in width for a total of thirty-nine point nine nine (39.99) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required

provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1126530 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

A 25%. penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 02/15/2017.
