ORDINANCE
CAMBRIA CHICAGO MAGNIFICENT MILE Acct. No. 398740 - 1
Permit No. 1125314

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to CAMBRIA CHICAGO MAGNIFICENT MILE, upon the terms and subject to the conditions of this ordinance to maintain and use one (1) sign(s) projecting over the public right-of-way attached to its premises known as 166 E. Superior St..

Said sign structure(s) measures as follows; along E. Superior Street:

One (1) at fourteen point four two (14.42) feet in length, two point five (2.5) feet in height and eighty-seven point five (87.5) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.,

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1125314 herein granted the sum of three hundred (\$300.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
