CHICAGO PARK DISTRICT Acct. No.
17339-40 Permit No. 1127440

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to CHICAGO PARK DISTRICT, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, six (6) Landscaping(s) on the public right-of-way for beautification purposes adjacent to its premises known as 8900 S. Green Bay Ave..

Said Landscaping(s) at S. Greenbay Ave from 89th Street to 90th Street measure(s):
One (1) at five hundred eighty-five (585) feet in length, and eighty (80) feet in width for a total of forty-six thousand eight hundred (46800) square feet.

Said Landscaping(s) at S. Greenbay Ave from 90th Street to Public Alley N. of 91st Street measure(s):
One (1) at four hundred thirty (430) feet in length, and eighty (80) feet in width for a total of thirty-four thousand four hundred (34400) square feet.

Said Landscaping(s) at 90th Street from S. Lake shore Dr to S. Mackinaw Ave. ublic Alley E. of Greenbay Ave 89th to 90th Street measure(s):
One (1) at six hundred eighty (680) feet in length, and eighty (80) feet in width for a total of fifty-four thousand four hundred (54400) square feet.

Said Landscaping(s) at Public Alley E. of Greenbay Ave 89th to 90th Street measure(s):
One (1) at five hundred eighty-five (585) feet in length, and twenty (20) feet in width for a total of eleven thousand seven hundred (11700) square feet.

Said Landscaping(s) at Public Alley E. of Greenbay Ave., 90th to 91st Street measure(s):
One (1) at six hundred ninety (690) feet in length, and twenty (20) feet in width for a total of thirteen thousand eight hundred (13800) square feet.

Said Landscaping(s) at Public Alley W. of Greenbay Ave. 90th to Public alley N. of 91st Street measure(s):
One (1) at four hundred thirty (430) feet in length, and twenty (20) feet in width for a total of eight thousand six

hundred (8600) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1127440 herein granted the sum of zero (\$.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 01/13/2021.
