WHEREAS, Following a send-off party attended by well-wishers at Mount Greenwood Park, Tommy traveled to Graz, Austria with his mother, aunt, brother, two friends, and his coach, who all cheered him on as he won a gold medal in the 500 meter race, and a bronze medal in the 777 meter race; and

WHEREAS, Serving as an example to us all of how hard work and perseverance can overcome adversity and lead to success, Tommy embodies the courage present in the Special Olympics athlete oath "Let me win, but if I cannot win, let me be brave"; and

WHEREAS, In addition to being a dedicated athlete, Tommy also gives of his own time by volunteering as an assistant coach at Mount Greenwood Park; therefore,
