BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single Unit (Detached House) District symbols and indications as shown on Map No. 12-J in an area bound by

A line 106 feet West of and parallel to South Springfield Avenue, the public alley next North and parallel to West 55th Street, a line 50 feet West of and parallel to South Springfield Avenue and West 55th Street

to those of a C1-1 Neighborhood Commercial District. SECTION 2. This ordinance takes effect after its passage and due publication.
