SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit District symbols and indicators as shown on Map No. 7-K in the area bounded by

West Diversey Avenue; North Kilpatrick Avenue; the public alley next south of and parallel to West Diversey Avenue; and a line 34.20 feet west of and parallel to North Kilpatrick Avenue.

The applicants seeks the change so that they can lease the storefront unit in its property to a Cricket Mobile Phone retail store, which will obtain the proper Chicago Business License. The mixed-use building will continue to have five residential dwelling units - continuing this legally non-conforming number of units (based on the square footage and current density).
