THE UNIVERSITY OF CHICAGO (FILE #56) Acct. No.

43697 - 75 Permit No. 1128095

Se It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to THE UNIVERSITY OF CHICAGO (FILE #56), upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Tieback System(s) under the public right-of-way adjacent to its premises known as 5640 S. Ellis Ave..

Said Tieback System(s) at S. Ellis Avenue measure(s):

One (1) at three hundred eight (308) feet in length, and sixty-five (65) feet in width for a total of twenty thousand twenty (20020) square feet.

Said Tieback System(s) at E. 57th Street measure(s):

One (1) at one hundred two (102) feet in length, and sixty-nine (69) feet in width for a total of seven thousand thirty-eight (7038) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1128095 herein granted the sum of one thousand three hundred ninety-six (\$1,396.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
