ORDINANCE

CRISTO REY JESUIT HIGH SCHOOL Acct. No. 49809 - 2 Permit No. 1127888

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to CRISTO REY JESUIT HIGH SCHOOL, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Drain Tile(s) under the public right-of-way adjacent to its premises known as 1851 W. 22nd PL.

Said Drain Tile(s) at West 22nd Place measure(s):

One (1) at one hundred nineteen (119) feet in length, and point three three (.33) feet in width for a total of thirty-nine point two seven (39.27) square feet.

Said Drain Tile(s) at Public Alley measure(s):

One (1) at one hundred fifty-five (155) feet in length, and point three three (.33) feet in width for a total of fifty-one point one five (51.15) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination) and Department of Water Management.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1127888 herein granted the sum of eight hundred (\$800.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs
