ORDINANCE

MADISON 901 CONDOMINIUM ASSOCIATION Acct.

No. 414953-1 Permit No. 1127080

Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to MADISON 901 CONDOMINIUM ASSOCIATION, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use four (4) Landscaping (s) on the public right-of-way for beautification purposes adjacent to its premises known as 901-25 W. Madison St..

Said Landscaping(s) at W MADISON ST measure(s):

One (1) at fifty-six (56) feet in length, and seven (7) feet in width for a total of three hundred ninety-two (392) square feet. One (1) at fifty-seven (57) feet in length, and seven (7) feet in width for a total of three hundred ninety-nine (399) square feet.

Two (2) at twenty-seven (27) feet in length, and seven (7) feet in width for a total of three hundred seventy-eight (378) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.


Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1127080 herein granted the sum of zero (\$.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the Crtyl5erforming work in the public way.
