ORDINANCE 2500 Milwaukee LLC Acct. No. 416799-1 Permit No. 1128054

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 2500 Milwaukee LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use four (4) Door Swing(s) on the public right-of-way adjacent to its premises known as 2500 N. Milwaukee Ave..

Said Door Swing(s) at Alley measure(s):

One (1) at six (6) feet in length, and two point eight three (2.83) feet in width for a total of sixteen point nine eight (16.98) square feet.

One (1) at two point nine eight (2.98) feet in length, and two point eight six (2.86) feet in width for a total of eight point five two (8.52) square feet.

Said Door Swing(s) at N. Milwaukee measure(s):

One (1) at two point eight three (2.83) feet in length, and two point zero five (2.05) feet in width for a total of five point eight (5.8) square feet.

One (1) at one point six (1.6) foot in length, and point four seven (.47) feet in width for a total of point seven five (.75) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1128054 herein granted the sum of three hundred (\$300.00) per annum in advance.
